Official Rules for Quick Draw Partner Play Promotion

Effective January 1, 2020

For every 20th wager of Quick Draw or Quick Draw with BULLSEYE sold by an employee of a Participating New Jersey Lottery Retailer during the Promotion Period, a separate, free duplicate game wager will be generated by the terminal for the employee that generated the 20th Quick Draw or Quick Draw with BULLSEYE wager.

- 1. The Quick Draw Partner Play Promotion ("Promotion") will run two (2) weeks out of each month (every other week) during the Promotion Period at Participating New Jersey Lottery Retailers as follows: January 6-12, January 20-26, February 3-9, February 17-23, March 2-8, March 16-22, 2020 (the "Promotion Period").
- 2. For purposes of this Promotion, "Participating New Jersey Lottery Retailers" or "Participating New Jersey Lottery Retailer" is/are defined as a/all retailer(s) in the New Jersey Lottery network that is/are categorized as either a bar or restaurant and "Active" in the New Jersey Lottery Enterprise System.
- 3. To participate in the Promotion, employees of Participating New Jersey Lottery Retailers (sometimes referred to in these Official Rules as "you") must be 18 years or older on the date of entry, a legal resident of the United States of America or the District of Columbia, and employed by a Participating New Jersey Lottery Retailer for the entire Promotion Period including up to the point of a prize award in connection with the Promotion, if any. Persons prohibited from purchasing New Jersey Lottery tickets or shares pursuant to N.J.A.C. 5:9-16 and N.J.A.C. 17:20-1.3 are prohibited from playing or participating in the Promotion.
- 4. For every 20th wager of Quick Draw or Quick Draw with BULLSEYE sold by an employee of a Participating New Jersey Lottery Retailer during the Promotion Period, a separate, free duplicate game wager will be generated by the terminal for the employee that generated the 20th Quick Draw or Quick Draw with BULLSEYE wager ("Duplicate Wager").
- 5. Any Duplicate Wager generated in connection with the Promotion for an employee of a Participating New Jersey Lottery Retailer will contain the following message printed on the ticket as shown below for demonstration purposes only:

"CLERK PARTNER PLAY FREE TICKET"



- 6. The Promotion may be suspended in the discretion of the New Jersey Lottery or its designee during times in which a second promotion is running concurrently. When the Quick Draw 50% Bonus Hours Promotion is running, the terminal will not produce a Partner Play ticket during that time period.
- 7. The New Jersey Lottery may declare any ticket generated in connection with a Quick Draw or Quick Draw with BULLSEYE wager or Duplicate Wager during the Promotion Period void, if it is stolen.
- 8. The New Jersey Lottery or its designee reserves the right to adjust, make exceptions for and disqualify New Jersey Lottery licensed retailers from participating in the Promotion and/or from qualifying as a Participating New Jersey Lottery Retailer at any time during the Promotion Period as deemed necessary by the New Jersey Lottery or its designee, in its/their discretion, to ensure the integrity of the Promotion and/or when determined by the New Jersey Lottery or its designee, in its/their discretion, to be in the best interest of the New Jersey Lottery.
- 9. The New Jersey Lottery or its designee reserves the right, without prior notice, to cancel, terminate, modify or suspend the Promotion at any time and for any reason, including but not limited to if the New Jersey Lottery or its designee determines that a virus, bug, unauthorized human intervention, fraud or other cause beyond its control has or is corrupting or affecting the administration, security, fairness or proper conduct of the Promotion.
- 10. By playing or participating in the Promotion, you hereby agree to (a) be bound by these Official Rules; (b) forever waive, release and discharge any and all claims and causes of action which you or your heirs, agents, representatives, executors, administrators, or any other persons acting on your behalf or on behalf of your estate have or may have against the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC and its/their respective agents, owners, operators, officers, directors, elected officials, members, shareholders, managers, contractors, subcontractors, employees, partners, and designees and each of its/their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC; and (c) forever waive, release and discharge the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC and its/their respective agents, owners, operators, officers, directors, elected officials, members, shareholders, managers, contractors, subcontractors, employees, partners, and designees and each of its/their respective parent companies, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the New Jersey Lottery and/or Northstar New Jersey Lottery Group, LLC from any and all liability, injury, damage, death, loss, litigation, claim, cause of action or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) your participation, in whole or in part in the Promotion; (ii) your acceptance, possession, use, or misuse of any prize awarded in connection with the Promotion; (iii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software in connection with the Promotion; (iv) the unavailability or inaccessibility of any transmissions or telephone or Internet service during the Promotion Period; (vi) unauthorized human intervention in any part of the Promotion; and (v) electronic or human error which may occur in the administration of the Promotion.
- 11. By playing or participating in the Promotion, you hereby irrevocably consent to the use and/or publication of your name, hometown, photograph(s), voice, and/or likeness by the New Jersey Lottery and/or its designee in any and all of its online, printed and social media advertisements, promotions,

publications, illustrations, and other Web content throughout the world in perpetuity, including but not limited to, on the World Wide Web, without payment or any other consideration to you. You hereby irrevocably authorize the New Jersey Lottery or its designee to edit, alter, copy, exhibit, publish and/or distribute, without any inspection or approval of use by you, your name, hometown, photograph(s), voice, and/or likeness for purposes of publicizing the New Jersey Lottery or for any other lawful purpose. In addition, you hereby irrevocably waive any right to royalties or other compensation arising from or related to the use and/or publication of your name, hometown, photograph(s), voice, and/or likeness.

- 12. By participating in the Promotion, you and each Participating New Jersey Lottery Retailer agree to fully comply with these Official Rules and to accept the decisions of the New Jersey Lottery or its designee as final and binding with regard to the Promotion. The Promotion is governed by the State Lottery Law, N.J.S.A. 5:9-1 through -25, and the Rules of the Lottery Commission, N.J.A.C. 17:20-1.1 through -12.23. The New Jersey Lottery Executive Director has the sole authority to resolve disputes. The New Jersey Lottery Executive Director's decision regarding any disputes shall be final.
- 13. These Official Rules may be changed at any time without prior notice if determined by the New Jersey Lottery or its designee to be in the best interests of the New Jersey Lottery.
- 14. All winners, tickets and transactions generated in connection with the Promotion are subject to New Jersey Lottery Rules and Regulations and State law. All prizes awarded in connection with the Promotion are subject to claim procedures, validation tests and other applicable requirements of the New Jersey Lottery. Liability for void or nonconforming ticket, if any, is limited to replacement of ticket with un-played ticket. Neither the New Jersey Lottery nor Northstar New Jersey Lottery Group, LLC is responsible for lost or stolen tickets. The Promotion is void where otherwise prohibited by law. The Promotion is not valid in combination with any other New Jersey Lottery promotion or coupon.
- 15. Winners are solely responsible for the payment of all applicable federal, State and local taxes associated with any prize awarded in connection with the Promotion.
- 16. Odds of receiving a Duplicate Wager are 1 in 20 based on all Quick Draw and Quick Draw with BULLSEYE wagers system wide at Participating New Jersey Lottery Retailers. Odds of winning a prize on the Duplicate Wager vary based on amount of numbers played; for detailed information see Quick Draw Odds and Prizes.
- 17. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision of these Official Rules. In the event that any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, in whole or in part, the other provisions will remain in full force and effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. The failure to enforce any provision of these Official Rules will not constitute a waiver of that or any other provision of these Official Rules.
